

Protects from #NSI while preventing syringe reuse



Equipped with a Safety SIP (Sharp Injury Prevention) Shield, with Auto disable feature not only safeguarding healthcare workers from accidental needle stick injuries (NSI's) but also preventing syringe reuse.

Features

Auto Disable Feature

- K1 design, equipped with a unique ring and lock mechanism, where the plunger breaks automatically, if reuse is attempted. Thus mitigating the risk of cross-contamination while reducing unsafe infection practices.
- Aspiration can be easily performed and can also be used for reconstitution of medication
- Available for both Curative and Immunization uses

SHIELD feature to avoid Needle Stick Injuries

- Added safety with SIP shield feature, which covers the needle after the injection procedure by gently pressing the needle cover on hard surface, thereby safeguarding the healthcare workers from needle stick injuries.
- Soft closing of the needle shield, avoids any blood spill and restrict aerosol contamination in the environment
- Audible click sound confirms locking of the needle, which can be performed using a single hand.

Caution

Don't push the plunger before taking the vaccine/medication.

Insert the needle in the vial and pull the plunger slowly until you notice restriction. Do not pull the plunger further after restriction

Do not use if the pack is previously open or damaged.

Use after checking Expiry Date.

Do not attempt to re-steralise and re-use

Instructions for use



Step 1
Open the pack and take the syringe out.




Step 2
Pull back the hinged cover to expose the (S.I.P) needle



Step 3
Insert the needle into the vial and withdraw fluid/medicament.
DONT PUSH THE PLUNGER FORWARD



Step 4
Flick barrel to move the air bubble to top. Push the plunger for desired dosage and expel air bubble.



Step 5
Inject the medicament by pushing the plunger



Step 6

Proceed with normal injection procedure, including aspiration for enabling vein location and alter giving the injection, by pusing plunger forward if the plunger is pulled back, it breaks automatically.



Step 7

Flick the SIP cover onto needle withdraw needle from patient body. Activate locking mechanism of safety (S.I.P.) needle cover, pressing the needle cover against a hard surface until you hear a click sound.



Step 8
In case of reconstitution after step 3 pull the piston backward to (extreme) keeping the needle downwars (to suck air).



Step 9
Release Total Fluid in Injection vial keeping the vial downward. Then proceed with normal injection predure by withdrawing the medicament as in step 2 followed by step no. 3, 4 & 5.
